
to develop, to organize,

in support of the School. This "Greater Things Fellowship" was a really big step in the right direction. Our present plan is an outgrowth of this Greater Things idea. The weakness of all our previous attempts was a lack of administration. The burden of administering these plans was laid upon the shoulders

of our already overburdened pastors. As a natural result the plans were not nearly so productive as they might have been. This need of a full-time promoter and administrator was obvious to all who were acquainted with the situation.

Faced with this evident necessity of promotion and administration, the executive committees of both the College and the national Alumni Association met together near the close of 1940 to consider the matter. As the outcome of this joint meeting I was chosen to become executive secretary of the national Alumni Association of Anderson College and Theological Seminary. To me the future of our College and Seminary is more promising than at any time in her history. The years immediately ahead should see us with all indebtedness paid and a greatly increased enrollment.

Method of Procedure

In this undertaking I expect to work along constructive and wellorganized lines. We shall seek, by organized effort, to enlist the wholehearted participation of every Alumnus in support of our Alma Mater.
